

Report on Senator Joseph Michael Seymour citations issued by MDWFP for hunting violations

Joseph Michael Seymour received a citation for **hunting from a public road** on **January 8, 2005**. He was convicted and fined \$193 on February 8, 2005. See Figure 1.
